MUNICIPAL ADMINISTRATION AND WATER SUPPLY DEPARTMENT

DISSOLUTION OF RAJAPALAYAM MUNICIPAL COUNCIL, RECONSTITUTION OF THE SAME WITH EFFECT FROM THE 12th NOVEMBER 2009 AND APPOINTMENT OF THE REGIONAL DIRECTOR OF MUNICIPAL ADMINISTRATION, TIRUNELVELI TO EXERCISE AND PERFORM ALL FUNCTIONS OF SAID MUNICIPAL COUNCIL AND ITS CHAIRMAN DURING THE PERIOD OF DISSOLUTION OF THE SAID MUNICIPAL COUNCIL.

Whereas, the State Government is of opinion that the Rajapalayam Municipal Council persistently makes default in performing duties imposed on it by law ;

And, Whereas, the explanations of the Rajapalayam Municipal Council have been called for under sub-section (1-A) of Section 41 of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920) and its explanations have been considered by the State Government ;

And, Whereas, it is considered that there is reasonable basis to dissolve the said Municipal Council ;

Now, therefore, in exercise of powers conferred by sub-section (1) of Section 41 of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920), the Governor of Tamil Nadu hereby dissolves the Rajapalayam Municipal Council with immediate effect and also directs that the said Municipal Council shall be reconstituted with effect from 12th November 2009.

And, in exercise of the powers conferred by clause (b) of sub-section (3) of Section 41 of the said Act, the Governor of Tamil Nadu hereby appoints the Regional Director of Municipal Administration, Tirunelveli, to exercise and perform all the functions of the Rajapalayam Municipal Council and its Chairman during the period of dissolution of the said Municipal Council.
