Whereas it appears to the Government of Tamil Nadu that the lands specified in the Schedule below and situated in the Vickramasingapuram Part-I Village, Ambasamudram Taluk, Tirunelveli District are needed for a public purpose for the formation of Gadana Dam Extension Scheme canal work. Notice to that effect is hereby given to all to whom it may concern in accordance with the provisions of sub-section (1) of Section 4 of the Land Acquisition Act, 1894 (Central Act I of 1894).

And, whereas, it has become necessary to acquire immediate possession of the lands specified in the schedule below the Governor of Tamil Nadu hereby directs that the lands be acquired under the provisions of sub section (1) of Section 17 of the said Act.

Now, therefore, in exercise of the powers conferred by sub-section (2) of section 4 of the said Act, the Governor of Tamil Nadu hereby authorises the Revenue Divisional Officer, Cheranmahadevi and his staff and workmen to exercise the power conferred by the said sub-section and

under clause (C) of Section 3 of the said Act. The Governor of Tamil Nadu hereby appoints the Revenue Divisional Officer, Cheranmahadevi to perform the functions of a Collector under section 5A of the said Act.

Under sub-section (4) of Section 17 of the said Act the Governor of Tamil Nadu hereby directs that in view of the urgency of the case the provisions of section 5A of the said Act shall not apply to this case.
