In exercise of the powers conferred by clause (a) of sub-section (1) and sub-section (2) of Section 2 of the Indian Tolls Act, 1851 (Central Act VIII of 1851), the Governor of Tamil Nadu hereby levies tolls for a further period of two years beyond 1st July 2009 and with effect on and from the 2nd July 2009, on the classes of Motor Vehicles entering into the Nilgiris District as specified in column (2) of the Table below at the rates specified in the corresponding entries in column (3) thereof:—

In exercise of the powers conferred by clause (a) of sub-section (1) read with sub-section (2) of Section 2 of the Indian Tolls Act, 1851 (Central Act VIII of 1851), as amended by the Tamil Nadu Tolls and Motor Vehicles Taxation (Amendment) Act, 1938 (Tamil Nadu Act VI of 1938) and the Indian Tolls (Tamil Nadu Amendment) Act, 1942 (Tamil Nadu Act XIV of 1942), the Governor of Tamil Nadu hereby levies tolls for a further period of two years beyond the 1st July 2009 and with effect on and from the 2nd July 2009 in respect of the following roads in the Nilgiris District with a facility for ingress into the Nilgiris District namely:—

- (i) Kunjapanai Kotagiri Mettupalayam road
- (ii) Pattavayal Sultan Bathery Gudalur road
- (iii) Thaloor Sultan Bathery Gudalur road
- (iv) Nadugani Calicut Gudalur road
- (v) Choladi Calicut Gudalur road
