ACQUISITION OF LANDS

Whereas, in exercise of the powers conferred by clause (1) of the Article 258 of the Constitution of India, the President of India, has in the Ministry of Food, Agriculture, Community Development and Co-operation (Department of Agriculture) Notification No. 4(1)65, General-II, dated 23rd April 1966, entrusted to the Government of Tamil Nadu with their consent, the functions of the Central Government under the Land Acquisition Act, 1894 (Central Act 1 of 1894), in relation to acquisition of lands for the purposes of the Union in this State:

And, whereas, it has already been decided that the compensation should be paid from the public revenue;

Now, therefore, in exercise of the powers conferred by Section 6 of the said Act, the Governor of Tamil Nadu hereby declares that the lands specified in the schedule below and measuring 5.2967 hectare be the same, a little more or less, are needed for a public purpose, to wit, for diversion of track between Thakkolam and Arakkonam by the Southern Railway. A Plan of the lands is kept in the Office of the Revenue Divisional Officer, Ranipet, Vellore District and may be inspected at any time during office hours.
