In exercise of the powers conferred under Section 65 of Madurai City Municipal Corporation Act, 1971 (Tamil Nadu Act XV of 1971), Section 27 and sub-section (1) of Section 43-B of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920) and sub-rule (4) of rule 99 of the Tamil Nadu Town Panchayats, Third Grade Municipalities, Municipalities and Corporations (Elections) Rules, 2006, the Tamil Nadu State Election Commission *interalia* notified the election to the office of Vice-Chairman of Thevarsolai Town Panchayat, the Nilgiris District to be held on 4-8-2009 in the S.O. second cited.
