PROCUREMENT OF INDIGENOUS COAL BY TAMIL NADU ELECTRICITY BOARD FROM THE PUBLIC SECTOR UNDERTAKINGS OF GOVERNMENT OF INDIA AT THE PRICES AS NOTIFIED BY THE GOVERNMENT OF INDIA AND TO IMPORT COAL THROUGH MMTC AT NEGOTIATED PRICE UNDER TAMIL NADU TRANSPARENCY IN TENDERS ACT.

Amendment to Notification

[G.O. Ms. No. 417, Finance (Salaries), 28th August 2009, Aavani 12, Thiruvalluvar Aandu-2040.]

Under clause (f) of Section 16 of the Tamil Nadu Transparency in Tenders Act, 1998 (Tamil Nadu Act 43 of 1998), the Governor of Tamil Nadu hereby makes the following amendment to the Finance Department Notification No. 121 published at page 1 of part II—Section 2 of the *Tamil Nadu Government Gazette* Extraordinary, dated the 28th April 2008.

2. The amendment hereby made shall come into force on and from 28th August, 2009.

AMENDMENT

In the said notificaton, for the expression

"the procurement of indigenou coal by Tamil Nadu Electricity Board from the Public Sector Undertakings of Government of India at the prices as notified by the Government of India and to import coal through Minerals and Metals Trading Corporation (MMTC) at negotiated price, subject to the Tamil Nadu Electricity Board's right to purchase Coal through competitive bidding as per the said Act."

the following expression shall be substituted, namely:—

"the procurement of indigenou coal by Tamil Nadu Electricity Board from the Public Sector Undertakings of Government of India at the prices as notified by the Government of India and import of coal through Central Public Sector Undertakings which have been in the business of importing coal and supplying to Government owned power utilities, at the price negotiated with the concerned Central Public Sector Undertakings or import of coal through Tamil Nadu Newsprint and Papers Limited, procured by means of competitive bidding, without prejudice to the right of Tamil Nadu Electricity Board to procure imported coal through competitive bidding as per the said Act."
