DISQUALIFICATION OF THIRU G. ELUMALAI, 2nd WARD MEMBER, ANDAMPALLAM VILLAGE PANCHAYAT, THIRUVANNAMALAI PANCHAYAT UNION, THIRUVANNAMALAI DISTRICT UNDER THE TAMIL NADU PANCHAYATS ACT.

Whereas, the opinion of the Tamil Nadu State Election Commission has been sought for, regarding the disqualification of Thiru G. Elumalai, 2nd Ward Member, Andampallam Village Panchayat, Thiruvannamalai Panchayat Union, Thiruvannamalai District, as required under sub-section (2) of Section 41 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994) as he has absented himself from the three consecutive meetings of the said Village Panchayat.

And, whereas the Tamil Nadu State Election Commission, after conducting the enquiry, has stated that a Notice No. Na.Ka.5258/2009-2/அ.க.ச.1, dated 23rd July 2009 sent to Thiru G. Elumalai, 2nd Ward Member, Andampallam Village Panchayat, Thiruvannamalai Panchayat Union, Thiruvannamalai District was returned on 30th July 2009 with the postal endorsement as 'returned to sender as party residing abroad' and it is therefore proved that he is living in a foreign country and on verification of the attendance register of Andampallam Village Panchayat, it is also confirmed that, Thiru G. Elumalai, 2nd Ward Member has not attended more than three consecutive meetings of the said Village Panchayat after the meeting held on 3rd December 2007 and thereby opined that the said Thiru G. Elumalai, 2nd Ward Member, Andampallam Village Panchayat, Thiruvannamalai Panchayat Union, Thiruvannamalai District, is disqualified to continue as Ward Member of the Andampallam Village Panchayat, under clause (i) of sub-section (3) of Section 38 of the said Act;

Now, therefore, under sub-section (1) of Section 41 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994), the Governor of Tamil Nadu hereby decides that Thiru G. Elumalai, 2nd Ward Member, Andampallam Village Panchayats, Thiruvannamalai Panchayat Union, Thiruvannamalai District, has become disqualified from holding the office of 2nd Ward Member of the Andampallam Village Panchayat, under clause (i) of sub-section (3) of Section 38 of the said Act as he has absented himself from the three consecutive meetings of the said Village Panchayat after the meeting held on 3rd December 2007.
