Under Section 5 of the Registration Act, 1908 (Central Act XVI of 1908), the Governor of Tamil Nadu hereby, with effect on and from the 13th November 2009 alters the limits of the Registration sub-districts specified in column (3) of the Table below and in the Kumbakonam Registration district and the Revenue district of Thanjavur by excluding the corresponding villages specified in column (2) thereof from the said Registration sub-districts and forms a new Registration sub-district of **Thiruppanandal** in the said Registration district and in the said Revenue district.
