ACQUISITION OF LANDS

Whereas it appears to the Government of Tamil Nadu that the Lands specified in the Schedule below and situated in Appanur, A.Punavasal, Veppankulam and Meenangudi Villages of Kadaladi Taluk are needed for a public purpose, to acquire for the formation of Malattar Anaikattu Scheme, notice to have effect is hereby given to all to whom it may concern in accordance with the provisions of sub-section (1) of Section 4 of the Land Acquisition Act, 1894 (Central Act 1 of 1894);

And whereas it has become necessary to acquire the immediate possession of the Lands specified in the Schedule below, the Governor of Tamil Nadu hereby directs that the lands be acquired under the provision of Section (2) of the Section 17 of the said Act.

Now, therefore in exercise of the powers conferred by sub-section (2) of Section 4 of the said act, the Governor of Tamil Nadu hereby authorizes the Special Tahsildar (Land Acquisition) Malattar Anaicut Scheme, Kamuthi and his staff workmen to exercise the powers conferred by the said sub-sections.

Under sub-section (2) of Section 17 of the said Act, the Governor of Tamil Nadu hereby directs that in view of the urgency of the case, the provisions of section 5A of the said Act, shall not apply in this case.
