ACQUISITION OF LANDS

The Governor of Tamil Nadu, having been satisfied that the lands specified in the Schedule below have to be acquired for Industrial Purpose, to wit, for the Madurai Airport Expansion Scheme and it having already been decided that the entire amount of compensation to be, awarded for the lands to be paid out of the lands, controlled or managed by Government. The following notice is issued under sub-section (1) of Section 3 of the Tamil Nadu Acquisition of Land for Industrial Purposes Act, 1997 (Tamil Nadu Act 10 of 1999):—

NOTICE

Under sub-section (1) of Section 3 of the Tamil Nadu Acquisition of Land for Industrial Purposes Act, 1997 (Tamil Nadu Act 10 of 1999), the Governor of Tamil Nadu hereby acquires the lands specified in the schedule below and measuring 7.54.0 hectares, to the same, a little more or less needed for Industrial Purpose, to wit, for the Madurai Airport Expansion Scheme.

Whereas in exercise of the powers conferred by clause (1) of the Articles 258 of the Constitution of India, the President of India has, in the Ministry of Food, Agriculture, Community Development and Co-operation (Department of Agriculture) Notification No.4 (i)/65, General I & II, dated the 23rd April, 1966 entrusted to the Government of Tamil Nadu with their consent, the function of the Central Government under the Land Acquisition Act, 1894 (Central Act I of 1894) in relation to Acquisition of Land for the purpose for the Union in this State.

And, whereas, the lands specified in the Schedule below are needed for a public purpose to wit for Road Over Bridge approach area due to the formation of Salem-Karur Broad Gauge Railwayline Project, notified to the effect is hereby given to all to whom it may concern in accordance with the provision of sub-section (1) of the Section 4 of the Land Acquisition Act, 1894 (Central Act I of 1894);

And, whereas it has become necessary to acquire the immediate possession of the Lands specified in the Schedule below, the Governor of Tamil Nadu hereby directs that the lands to be acquired under the provisions of sub-section (2) of Section 17 of the said Act;

Now, therefore, in exercise of the powers conferred by sub-section (2) of Section 4 of the said Act, the Governor of Tamil Nadu hereby authorise the Special Tahsildar (L.A.), Unit-I, Salem-Karur Broad Gauge Railwayline Project, Namakkal and his Staff and Workman to exercise the powers

conferred by the said sub-section under clause (c) of Section 3 of the said Act, the Governor of Tamil Nadu hereby appoints the Special Tahsildar (L.A.), Unit-I, Salem-Karur Broad Gauge Railwayline Project, Namakkal to perform the functions of the Collector under the said Act;

Under sub-section (4) of Section 17 of the said Act, the Governor of Tamil Nadu hereby directs that, in view of the urgency of the case, the provisions of Section 5-A of the Act shall not apply to this case.
