NOTIFICATIONS UNDER TAMIL NADU RELIEF UNDERTAKINGS (SPECIAL PROVISIONS) ACT.

DECLARATION OF TAMIL NADU TEXTILE CORPORATION LIMITED, COIMBATORE AS RELIEF UNDERTAKING FOR CERTAIN PERIOD.

Whereas, the Government are satisfied that with view to enabling the continued running of Tamil Nadu Textile Corporation Limited, Coimbatore, a State Industrial Undertaking as a measure of preventing, or of providing relief against unemployment, it is necessary and expedient to declare the said State Industrial Undertaking as a relief Undertaking in the Public interest.

Now, Therefore, in exercise of the powers conferred by Section 3 of the Tamil Nadu Relief Undertakings (Special Provisions) Act, 1969 (Tamil Nadu Act 21 of 1969), the Governor of Tamil Nadu hereby declares that Tamil Nadu Textile Corporation Limited, Coimbatore, a State Industrial Undertaking, shall for a period of one year with effect on and from the date of publication of this notification, be a relief undertaking for the purpose of the said Act.

DIRECTION REGARDING SUSPENSION FROM OPERATION OF ALL CONTRACTS, ASSURANCES OF PROPERTY, ETC., OF TAMIL NADU TEXTILE CORPORATION LIMITED, COIMBATORE.

No. II(2)/HHTK/104(a-2)/2009.

In exercise of the powers conferred by clauses (a) and (b) of Section 4 of the Tamil Nadu Undertakings (Special Provisions) Act, 1969 (Tamil Nadu Act 21 of 1969), the Governor of Tamil Nadu hereby directs that in relation to the Relief Undertaking, namely the Tamil Nadu Textile Corporation Limited, Coimbatore:—

- (a) The Industrial Disputes Act, 1947 (Central Act XIV of 1947) shall apply with the omission of Chapter V-B and Section 33-C; and
- (b) All contracts, assurances of property, agreements, assignments, standing orders or other instruments in force, to which the said relief undertaking is a party or which may be applicable to the said relief undertaking, immediately before the date with effect on and from which the said relief undertaking was declared as a relief undertaking, shall be suspended in operation and that all the rights, privileges, obligations and liabilities accruing or arising there under before the said date, shall be suspended with effect on and from the said date.
