In supercession of the orders already issued in G.O. (Ms) No. 157, Highways (HF.2) Department, dated 13th June 2007, published in no. II(2)/HW/357/2007 at page No. 259, of *Tamil Nadu Government Gazette* No. 29, dated 25th July 2007, now the Governor of Tamil Nadu having been satisfied that the lands specified in the Schedule below are required for the purpose of formation of Tiruvannamalai Bypass road and it having already been decided that the entire amount of compensation to be awarded for the lands is to be paid by the Divisional Engineer (Highways) Tamil Nadu Road Sector Project, Tiruvannamalai after considering the cause shown by the owner or other person having interest on such land, as the case may be, do hereby publish the following notice under sub-section (1) of section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002);

NOTICE

Under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002), the Governor of Tamil Nadu hereby acquires the lands specified in the Schedule below admeasuring 0.46.0 Hectare, to the same, a little more or less needed for the purpose of formation of Tiruvannamalai Bypass Road.
