The following Order of the Election Commission of India, Nirvachan Sadan, Ashoka Road, New Delhi-110 001, dated 30th July, 2010 [8 Shravana, 1932 (Saka)] is republished:—

No. 76/TN-HP/2009(8).—Whereas, the Election Commission of India is satisfied that Sh. Balamurugan a contesting candidate at the General Election to Lok Sabha, 2009 from 35. Ramanathapuram Parliamentary Constituency has failed to lodge his account of election expenses as required by the Representation of the People Act, 1951 and the Rules made thereunder;

And, whereas, the said candidate could not submit his representation/account of election expenditure till date under the said rule;

And, whereas, in the supplementary report of the District Election Officer and District Collector, Ramanathapuram District has stated that he has not yet filed his account of election expenses;

Now, therefore, in pursuance of Section 10A of the said Act, the Election Commission hereby declares Sh. Balamurugan to be disqualified for being chosen as and for being a member of either House of Parliament or the Legislative Assembly or Legislative Council of a State or Union Territory for a period of three years from the date of this Order.
