Whereas, in exercise of the powers conferred by clause (1) of Article 258 of the Constitution of India, the President of India has, in the Ministry of Food, Agriculture, Community Development and Co-operation (Department of Agriculture), Notification No. 4(1)/65, General II, dated 23rd April 1966, entrusted to the Government of Tamil Nadu with their consent, the function of the Central Government under the Land Acquisition Act, 1894 (Central Act 1 of 1894), in relation to acquisition of lands, for the purposes of the Union in this State;

And, whereas, it has already been decided that the compensation should be paid from the public revenue.

Now, therefore, in exercise of the powers conferred by Section 6 of the said Act, the Governor of Tamil Nadu hereby declares that the lands specified in the schedule below and measuring 0.18.5 hectare, be the same, a little more or less, are needed for public purpose, to wit, for the formation of New Broad Gauge Railway Line between Nagapattinam to Thiruthuraipoondi (via) Tirukkuvalai Project in Thiruvidamaruthur Village, Thirukkuvalai Taluk, Nagapattinam District by the Southern Railway.
