The Government of Tamil Nadu having been satisfied that the lands specified in the Schedule below has to be acquired for the public purpose and it having already been decided that the entire amount of compensation is to be paid by the Thanjavur Paddy Processing Research Centre, authorities towards compensation to be awarded for the land, the following Declaration is issued under Section 6 of the Land Acquisition Act, 1894 (Central Act I of 1894).

DECLARATION
