And whereas Gazette copies of the said draft amendments to the said Rules in which they were published were made available to the public on the 25th October, 2010.

Now, therefore, in exercise of the powers conferred by sub-section (1) of Section 32 of the Mahatma Gandhi National Rural Employment Guarantee Act, 2005 (Central Act 42 of 2005), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu State Employment Guarantee Fund Rules, 2008.

AMENDMENTS

In the said Rules,-

- (1) for the expressions "Tamil Nadu State Employment Guarantee Fund" wherever it occurs, the expression "State Employment Guarantee Fund Tamil Nadu" shall be substituted;
- (2) in rule 6, the expression "including the expenses of the State Employment Guarantee Council and the Society" shall be omitted.
