Whereas, the Tamil Nadu State Election Commission issued orders in the S.O.No.39/2013/TNSEC/PE-2, dated 7-10-2013 and as published in *Tamil Nadu Government Gazette* Extraordinary No.300, dated 21-10-2013 in No. VI(2)/213(b-3)/2013 with regard to Tiruvallur District disqualifying the contested candidates those who have failed to lodge their election expenses accounts as required by or under the relevant section of the Tamil Nadu Pachayats Act, 1994 and the rules made there under, for a period of three years from the date of issue of orders for being elected as a member or president as the case may be;

Whereas, several written representations along with the acknowledgement receipts for submission of election expenses accounts before the Officers concerned were received from some of the candidates of Tiruvallur District who were disqualified;

Wheres, considering the *prima-facie* of the representations, the Tamil Nadu State Election Commission constituted a Committee to inquire into this matter and report;

Wheres, in anticipation of the inquiry report, the Tamil Nadu State Election Commission withheld the first read above until further orders *vide* Statutory Order No. 46/2013/TNSEC/PE-2, dated 19-12-2013 as published in *Tamil Nadu Government Gazette* Extraordinary No. 383, dated 19-12-2013 in No. VI(2)/262(a)/2013;

WHERES, the Committee inquired into the matter and submitted report to the Commission and further report was called for from the District Election Officer/District Collector, Tiruvallur District and the same has been received from him;

Wheres, as per the report of the Committee sent by the Tamil Nadu State Election Commission and the report of the District Election Officer/District Collector, Tiruvallur District in the reference third read above, the reconsideration of disqualification has become necessary for the following candidates as the reports say that these candidates had already submitted their election expenses account and it was wrongly reported that they did not file the accounts:-

AND WHEREAS, now the Tamil Nadu State Election Commission has come to a stage of withdrawing the Statutory Order No.46/2013/TNSEC/PE-2, dated 19-12-2013 which withholds the Statutory Order No.39/2013/TNSEC/PE-2, dated 7-10-2013 disqualifying the candidates who contested for elections in Rural Local Bodies in Tiruvallur District and not submitted their election expenses accounts.

Now, Therefore, taking into consideration of the above facts, Tamil Nadu State Election Commission, in exercise of the powers conferred under Article 243-K of Constitution of India and sub-section (4) of section 37 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994), read with sub-rule (13) of rule 120 and sub-rule (1) of rule 143 of the Tamil Nadu Panchayats (Elections) Rules, 1995, hereby orders that the S.O. No. 46/2013/TNSEC/PE-2, dated 19-12-2013 is revoked except in cases of the candidates whose names are mentioned against the SI.Nos. 1, 248, 658 and 754 of S.O. No.39/2013 TNSEC/PE-2, dated 7-10-2013 and the disqualification ordered in respect of all other candidates of Rural Local Bodies in Tiruvallur District issued in its Statutory Order first read above holds good.

Whereas, the Tamil Nadu State Election Commission issued orders in the S.O. No.35/2013/TNSEC/ME-II, dated 4-10-2013 as published in *Tamil Nadu Government Gazette* Extraordinary, No.289, dated 7-10-2013 in No.VI(2)/207(a-28)/2013 with regard to Tiruvallur District, disqualifying the contested candidates those who have failed to lodge their election expenses accounts as required by or under the relevant section of the Tamil Nadu District Municipalities Act, 1920 and the rules made thereunder, for a period of three years from the date of issue of orders for being elected as Chairman or Councillor or Ward Member as the case may be;

Whereas, several written representations along with the acknowledgement receipts for submission of election expenses accounts before the Officers concerned were received from some of the candidates of Tiruvallur District who were disqualified;

Whereas, considering the *Prima-Facie* of the representations, the Tamil Nadu State Election Commission constituted a Committee to inquire into this matter and report;

Whereas, in anticipation of the inquiry report, the Tamil Nadu State Election Commission withheld the Statutory Order first read above until further orders *vide* Statutory Order No.46/2013/TNSEC/PE2, dated 19-12-13 as published in *Tamil Nadu Government Gazette* Extraordinary No.383, dated 19-12-2013 in No.VI(2)/262(a)/2013;

Whereas, the Committee inquired into the matter and submitted report to the Commission; and further report was called for from the District Election Officer/District Collector, Tiruvallur and the same has been received from him;

Whereas, as per the report of the Committee sent by the Tamil Nadu State Election Commission and the report of the District Election Officer/District Collector, Tiruvallur District in the reference third, and forth read above, the reconsideration of disqualification has become necessary for the following candidates as the reports say that these candidates had already submitted their election expenses account and it was wrongly reported that they did not file the accounts:

Whereas, the District Election Officer/District Collector, Tiruvallur has also recommended in the reference fifth cited for reconsideration of the disqualification of Tmt. S. Govindhammal, No.3, Paul Mohandoss Street, Poonamallee Municipality (SI.No.268) stating that the show cause notice related to her had not been served directly to her and due to her absence it was served to her family member as per section 331(1)(b) of the Tamil Nadu District Municipalities Act, 1920 and this information had not been transmitted to the individual;

Whereas, a detailed further inquiry is to be held by the Tamil Nadu State Election Commission with regard to disqualification of Tmt. S. Govindhammal;

AND WHEREAS, now the Tamil Nadu State Election Commission has come to a stage of withdrawing the Statutory Order No. 46/2013/TNSEC/PE2, dt.19-12-13 which withholds the Statutory Order No.35/2013/TNSEC/ME2, dt. 4-10-13 disqualifying the candidates who contested for elections in urban local bodies in Tiruvallur District and not submitted their election expenses accounts;

Now, Therefore, taking into consideration of the above facts, the Tamil Nadu State Election Commission decided to hold a detailed enquiry with regard disqualification of the candidates mentioned in the Table shown above and the candidate Tmt. S. Govindhammal, No.3, Paul Mohandoss Street, Poonamallee Municipality, the Tamil Nadu State Election Commission in exercise of the powers conferred under Article 243-ZA of the Constitution of India and sub-rule (13) of rule 116 and rule 139 of the Tamil Nadu Town Panchayats, Third Grade Municipalities, Municipalities and Corporation (Elections) Rules, 2006, pending enquiry with regard to candidates mentioned above hereby orders that the Statutory Order No.46/2013/TNSEC/PE2, dt.19-12-13 is revoked except in cases of the candidates whose names are mentioned against the SI.Nos. 2, 4, 7, 35, 37, 49, 50, 145, 163, 210, 268, 388, 413 and 426 of Statutory Order No.35/2013/TNSEC/ME2, dt. 4-10-2013 and the disqualification ordered in respect of all other candidates of urban local bodies in Tiruvallur District issued in its Statutory Order first read above holds good.
