MARKET BORROWING PROGRAMME OF STATE GOVERNMENT OF AUCTION

The following Notification is published:—

#### NOTIFICATION

*[No.294(L)/W&M-II/2015]*

Government of Tamil Nadu hereby notifies the sale of Tamil Nadu Government Stock (Securities) of **Ten year** tenure for an aggregate amount of **Rs.1200.00 Crore** (Nominal). **The State Government will have the option to retain an additional amount of upto Rs.300.00 Crore.** The sale will be subject to the terms and conditions spelt out in this notification (called Specific Notification) as also the terms and conditions specified in the General Notification No.170(L)/W&M-II/2007, dated 19th July 2007 of Government of Tamil Nadu.

#### **Object of the Loan:**

- (i) To Finance Part of Capital expenditure of Plan Schemes and other Development Schemes under execution.
- (ii) Consent of Central Government has been obtained to the floatation of this loan as required by Article 293(3) of the Constitution of India.

#### **Method of Issue:**

2. The Government stock will be sold through the Reserve Bank of India, Mumbai Office (PDO), Fort, Mumbai-400 001 by auction in the manner as prescribed in paragraph 6.1 of the General Notification No.170 (L)/ W&M-II/2007, dated July 19, 2007 at a coupon rate to be determined by the Reserve Bank of India at the yield based auction under multiple price format.

#### **Allotment to Non-competitive Bidders:**

3. The Government Stock up to 10% of the notified amount of the sale will be allotted to eligible individuals and institutions subject to a maximum limit of 1% of the notified amount for a single bid as per the Revised Scheme for Non-competitive Bidding Facility in the Auctions of State Government Securities of the General Notification (Annexure II).

**Place and Date of Auction:**

4. The auction will be conducted by the Reserve Bank of India, at its Mumbai Office, Fort, Mumbai -400 001 on **August 25, 2015**. Bids for the auction should be submitted in electronic format, on the Reserve Bank of India Core Banking Solution (E-Kuber) System as stated below on **August 25, 2015**.

(a) The competitive bids shall be submitted electronically on the Reserve Bank of India Core Banking Solution (E-Kuber) System between 10.30 A.M. and 12.00 P.M.

(b) The non-competitive bids shall be submitted electronically on the Reserve Bank of India Core Banking Solution (E-Kuber) System between 10.30 A.M. and 11.30 A.M.

**Result of the Auction:**

5. The result of the auction shall be displayed by the Reserve Bank of India on its website on the same day. The payment by successful bidders will be on **August 26, 2015**.

**Method of Payment:**

6. Successful bidders will make payments on **August 26, 2015** before close of banking hours by means of cash, bankers' cheque/pay order, demand draft payable at Reserve Bank of India, Mumbai/Chennai or a cheque drawn on their account with Reserve Bank of India, Mumbai (Fort)/Chennai.

**Tenure:**

7. The Stock will be of **10** year tenure. The tenure of the stock will commence on **August 26, 2015**.

**Date of Repayment:**

8. The loan will be repaid at par on **August 26, 2025**.

**Rate of Interest:**

9. The cut-off yield determined at the auction will be the coupon rate per cent per annum on the Stock sold at the auction. The interest will be paid on **February 26** and **August 26**.

**Eligibility of Securities:**

10. The investment in Government Stock will be reckoned as an eligible investment in Government Securities by banks for the purpose of Statutory Liquidity Ratio (SLR) under Section 24 of the Banking Regulation Act, 1949. The stocks will qualify for the ready forward facility.
