WHEREAS, in G.O.(Ms)No.157, Municipal Administration and Water Supply Department, dated 18-08-2008 a list of Parks, Play Fields and Open Spaces in the area within the Jurisdiction of the Rajapalayam Municipality was revised under sub-section (4) of Section 5 of the Tamil Nadu Parks, Play-fields and Open Spaces (Preservation and Regulation) Act, 1959 (Tamil Nadu Act 26 of 1959) and the same was published as Municipal Administration and Water Supply Department Notification No.II(2)/MAWS/407/2008, in pages 299 and 300 of Part II–Section 2 of the *Tamil Nadu Government Gazette*, dated the 10th September 2008.
