COMMERCIAL TAXES AND REGISTRATION DEPARTMENT

AMENDMENTS TO THE TAMIL NADU ENTERTAINMENTS TAX RULES, 1939.

[G.O. Ms. No. 120, Commercial Taxes and Registration (C1), 14th October 2016, பரட்டாசி 28, துன்முகி, திருவள்ளுவர் ஆண்டு–2047.]

No. SRO A-17(b)/2016.

In exercise of the powers conferred by sub-sections (1) and (2) of section 16 of the Tamil Nadu Entertainments Tax Act, 1939 (Tamil Nadu Act X of 1939), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Entertainments Tax Rules, 1939:-

2. The amendments hereby made shall come into force on the 14th October, 2016.

AMENDMENTS

In the said Rules,-

1. for rule 20, the following rule shall be substituted, namely:-"20. (1) Any proprietor, who pays the tax on the basis of returns shall, after getting registration, apply to the Entertainments Tax Officer atleast three days before the entertainment, furnishing details as to the date, time and nature of the entertainment in electronic Form III, and also the rates of payment for admission to it. Except in cases where the Entertainments Tax Officer has by an order in writing, exempted the proprietor from doing so, the application shall be accompanied by the register in electronic Form II and the tickets of all classes proposed for issue, the tickets of each class being printed in a different colour and bearing separate serial numbers. Each ticket shall have a foil and counterfoil, the foil bearing the words "To be detached at the entrance and given to the buyer" and the counterfoil bearing the words "To be detached at the entrance and retained by the proprietor". The serial number shall be printed on both foil and the counterfoil. The foil shall be at least double the length of the counterfoil, the foil and the counterfoil shall be of the sizes at least 8 cm x 4 cm and 4 cm x 4 cm respectively or any larger proportionate sizes:

Provided that the electronic tickets for admission to entertainments including advance booking coupons issued by the proprietor online or in counter shall be with the inscription of the name of the theatre in both Tamil and English and other details including the rate of admission and taxes either in Tamil or in both Tamil and English. Such tickets shall be exchanged with the tickets already sealed by the Entertainments Tax Officer at the ticket counter.

(2) Tickets already printed otherwise than as above shall be valid till the old stocks of tickets are exhausted.

(3) The Entertainments Tax Officer may, for sufficient reasons, condone the delay in the presentation of the application in the electronic Form III provided it is presented atleast twenty four hours prior to the commencement of the entertainment.";

2. for rule 21-B, the following rule shall be substituted, namely:-

"21-B. (1) The proprietor of every place from where television exhibition is provided shall, within thirty days from the date of commencement of such television exhibition, submit to the Entertainments Tax Officer an application for registration in electronic Form I along with the supporting documents.

(2) Every application for registration in electronic Form I shall be filed with the recent passport size photographs along with digital signature of the proprietor, in the case of proprietorship concern, or the managing partner or anyone of the partners, in the case of a partnership concern and the authorized person, in all other cases:

Provided that the applicant holding no digital signature shall submit the application electronically and furnish the manually signed hard copy of the electronic application before the registering authority within ten days from the date of such submission, as proof, along with copies of relevant documents necessary for registration like Voter identity card, Driving license, Passport, Permanent Account Number card, Unique Identification Card (Aadhaar card), etcetera:

Provided further that the proprietor, managing partner, or the authorized person, as the case may be, shall appear before the Entertainments Tax Officer, when called upon to do so and sign before him on the copies of the photographs in case of submission of digitally unsigned application.

(3) On receipt of the application in electronic Form I, the Entertainments Tax Officer shall after satisfying himself as to the correctness of the information furnished in the application and the uploaded documents and after making such enquiry as he considers necessary within thirty days from the date of receipt of application, issue a digitally signed electronic certificate of registration in Form I-A to the applicant.

(4) Where a proprietor of television exhibition transfers his business to another, the transferee shall apply for a fresh Certificate of Registration. The Entertainments Tax Officer shall issue the Certificate of Registration after following the procedure laid down in sub-rule (3).

(5) For any amendments other than transfer of business, such as change in constitution and place of business, the proprietor shall file an application in electronic Form I-AA with supporting documents and with digital signature certificate electronically:

Provided that the applicant holding no digital signature shall submit the application electronically and furnish the manually signed hard copy of the electronic application before the registering authority within ten days from the date of such submission, as proof, along with copies of relevant documents necessary for registration like Voter identity card, Driving license, Passport, Permanent Account Number card, Unique Identification Card (Aadhaar card), etcetera:

Provided further that the proprietor, managing partner, or the authorized person, as the case may be, shall appear before the Entertainments Tax Officer, when called upon to do so and sign before him on the copies of the photographs in case of submission of digitally unsigned application.";

3. for rule 21-D, the following rule shall be substituted, namely:-

"21-D. (1) The proprietor of every amusement shall, within seven days before the commencement of the amusement, submit to the Entertainments Tax Officer an application for registration in electronic Form I-B along with the supporting documents electronically.

(2) The proprietor of every recreation parlour shall, within thirty days before the commencement of the recreation parlour, submit to the Entertainments Tax Officer an application for registration in electronic Form I-B along with the supporting documents electronically.

(3) Every application for registration in electronic Form I-B shall be filed with the recent passport size photograph along with digital signature of the proprietor, in the case of proprietorship concern or the managing partner or anyone of the partners, in the case of a partnership concern and the authorized person, in all other cases:

Provided that the applicant holding no digital signature shall submit the application electronically and furnish the manually signed hard copy of the electronic application before the registering authority within ten days from the date of such submission, as proof, along with copies of relevant documents necessary for registration like Voter identity card, Driving license, Passport, Permanent Account Number card, Unique Identification Card (Aadhaar card), etcetera:

Provided further that the proprietor, managing partner, or the authorized person, as the case may be, shall appear before the Entertainments Tax Officer, when called upon to do so and sign before him on the copies of the photographs in case of submission of digitally unsigned application.

(4) On receipt of the application in electronic Form I-B, the Entertainments Tax Officer shall, after satisfying himself as to the correctness of the information furnished in the application and the uploaded documents and after making such enquiry as he considers necessary, issue a digitally signed electronic Certificate of Registration in Form I-C to the applicant within thirty days from the date of receipt of application or the proof for electronic payment of prescribed fees, whichever is later.

If the certificate of registration is not received by the applicant within thirty days from the date of his application or the payment of the prescribed fees, whichever is later, or if no notice giving him an opportunity of being heard is received by him within the said period, the applicant shall be deemed to have been duly registered.

(5) Where a proprietor providing amusement or recreation parlour transfers his business to another, the transferee shall apply for a fresh Certificate of Registration. The Entertainments Tax Officer shall issue the Certificate of Registration after following the procedure laid down in sub-rule (4).

(6) For any amendments other than transfer of business, such as change in constitution and place of business, the proprietor shall file an application in electronic Form I-AA with supporting documents and with digital signature certificate electronically:

Provided that the applicant holding no digital signature shall submit the application electronically and furnish the manually signed hard copy of the electronic application before the registering authority within ten days from the date of such submission, as proof, along with copies of relevant documents necessary for registration like Voter identity card, Driving license, Passport, Permanent Account Number card, Unique Identification Card (Aadhaar card), etcetera:

Provided further that the proprietor, managing partner, or the authorized person, as the case may be, shall appear before the Entertainments Tax Officer, when called upon to do so and sign before him on the copies of the photographs in case of submission of digitally unsigned application.";

4. in rule 21-G,-

(a) for sub-rules (1), (2) and (3), the following sub-rules shall be substituted, namely:-

"(1) The Indian Premier League conducting any cricket tournament or the Board of Control for Cricket in India conducting the Champions League Twenty 20 Cricket Tournament shall, atleast thirty days before the commencement of the Cricket Tournament, submit to the Entertainments Tax Officer an application for registration in electronic Form I-F along with the supporting documents electronically.

(2) Every application for registration in electronic Form I-F shall be filed with the recent passport size photographs along with digital signature of the applicant or the authorized person:

Provided that the applicant holding no digital signature shall submit the application electronically and furnish the manually signed hard copy of the electronic application before the registering authority within ten days from the date of such submission, as proof, along with copies of relevant documents necessary for registration like Voter identity card, Driving license, Passport, Permanent Account Number card, Unique Identification Card (Aadhaar card), etcetera:

Provided further that the proprietor, managing partner, or the authorized person, as the case may be, shall appear before the Entertainments Tax Officer, when called upon to do so and sign before him on the copies of the photographs in case of submission of digitally unsigned application.

(3) On receipt of the application in electronic Form I-F, the Entertainments Tax Officer shall, after satisfying himself as to the correctness of the information furnished in the electronic application and the uploaded documents and after making such enquiry as he considers necessary within thirty days from the date of receipt of application, issue a digitally signed electronic certificate of registration in Form I-G to the applicant.";

(b) for sub-rule (5), the following sub-rule shall be substituted, namely:-

"(5) For any amendments other than transfer of business, such as change in constitution and place of business, the proprietor shall file an application in electronic Form I-AA with supporting documents and with digital signature certificate electronically:

Provided that the applicant holding no digital signature shall submit the application electronically and furnish the manually signed hard copy of the electronic application before the registering authority within ten days from the date of such submission, as proof, along with copies of relevant documents necessary for registration like Voter identity card, Driving license, Passport, Permanent Account Number card, Unique Identification Card (Aadhaar card), etcetera:

Provided further that the proprietor, managing partner, or the authorized person, as the case may be, shall appear before the Entertainments Tax Officer, when called upon to do so and sign before him on the copies of the photographs in case of submission of digitally unsigned application.";

(c) for sub-rules (8) and (9), the following sub-rules shall be substituted, namely:-

"(8) The Indian Premier League or the Board of Control for Cricket in India conducting the Champions League Twenty 20 cricket tournament shall submit a return in electronic Form II-F showing the gross collection for each month and the amount or amounts actually collected by him by way of tax during the month, separately, by affixing the digital signature certificate on or before the 10th day of the succeeding month along with the proof of electronic payment of tax payable under section 4-J for the month for which the return relates:

Provided that if the return is not accompanied by digital signature certificate, then the return for each month shall be submitted electronically and a duly signed copy of the same shall be submitted to the Entertainments Tax Officer on or before the 10th day of the succeeding month along with the proof of electronic payment of tax payable under section 4-J for the month for which the return relates.

(9) The Indian Premier League conducting any cricket tournament or the Board of Control for Cricket in India conducting the Champions League Twenty 20 cricket tournament shall pay the tax due electronically into the Government Treasury through the website of the Commercial Taxes Department, using either on-line net banking or on-line linked off-line payment facility of the Banks authorized by the Government.";

5. after rule 21-G, the following rule shall be inserted, namely:-

"21-H. (1) The proprietor of every cinematograph exhibition conducted in a permanent theatre or semi-permanent theatre, including open air theatre and touring talkies shall, within seven days before the commencement of the cinematograph exhibition, submit to the Entertainments Tax Officer an application for registration in the electronic Form I-H along with the supporting documents electronically.

(2) Every application for registration in electronic Form I-H shall be filed with the recent passport size photographs along with digital signature of the applicant or the authorized person:

Provided that the applicant holding no digital signature certificate shall submit the application electronically and furnish the manually signed hard copy of the electronic application before the registering authority within ten days from the date of such submission, as proof, along with copies of relevant documents necessary for registration like Voter identity card, Driving license, Passport, Permanent Account Number card, Unique Identification Card (Aadhaar card), etcetera:

Provided further that the proprietor, managing partner, or the authorized person, as the case may be, shall appear before the Entertainments Tax Officer, when called upon to do so and sign before him on the copies of the photographs in case of submission of digitally unsigned application:

Provided also that the proprietor, managing partner, or the authorized person as the case may be, already registered under the Act shall furnish such details to the registering authority in the electronic Form I-H along with the proof of such registration, within two months from 14th October, 2016 and in new case, within thirty days before the commencement of the entertainment, in electronic Form I-H.

(3) On receipt of the application in electronic Form I-H, the Entertainments Tax Officer shall, after satisfying himself as to the correctness of the information furnished in the application and the uploaded documents and after making such enquiry as he considers necessary within thirty days from the date of receipt of application, issue a digitally signed electronic certificate of registration in Form I-I to all the applicants including those already registered.

(4) Where a proprietor providing cinematograph exhibition through permanent theatre or semi-permanent theatre, including open air theatre and touring talkies transfers his business to another, the transferee shall apply for a fresh registration electronically. The Entertainments Tax Officer shall issue the digitally signed electronic Certificate of Registration after following the procedure laid down in sub-rule (3).";

6. for rule 28, the following rule shall be substituted, namely:-

"28. The Proprietor shall also forward to the Entertainments Tax Officer a return in electronic Form V showing the number and classes of season tickets and complimentary season tickets issued, the period for which such tickets are available and the gross sum realized thereby, along with the return for the first of the series of entertainments for admission to which such season tickets and complimentary season tickets are valid. Such return shall also be affixed with digital signature certificate and accompanied by the proof of electronic payment of tax due thereon. If any season ticket and complimentary season ticket are valid it shall be shown in the electronic return to be filed for the entertainment which takes place next after the issue of the tickets.";

7. in rule 30-A, for sub-rules (1) and (2), the following sub-rules shall be substituted, namely:-

"(1) Every proprietor of television exhibition shall submit a return in electronic Form II-B showing the total collections for each month and the amount or amounts actually collected by him by way of tax during the month,

separately, by affixing the digital signature certificate on or before the 10th day of the succeeding month along with the proof of electronic payment of tax payable under section 4-E for the month for which the return relates:

Provided that if the return is not accompanied with digital signature certificate, then the return for each month shall be submitted electronically and a duly signed hard copy of the same shall be submitted to the Entertainments Tax Officer on or before the 10th day of the succeeding month along with the proof of electronic payment of tax payable under section 4-E for the month for which the return relates.

(2) Every proprietor providing amusement or recreation parlour shall submit a return in electronic Form II-D showing the total collections for each month and the amount or amounts actually collected by him by way of tax during the month, separately, by affixing the digital signature certificate on or before the 10th day of the succeeding month along with the proof of electronic payment of tax payable under section 4-F or section 4-G for the month for which the return relates:

Provided that if the return is not accompanied with digital signature certificate, then the return for each month shall be submitted electronically and a duly signed hard copy of the same shall be submitted to the Entertainments Tax Officer on or before the 10th day of the succeeding month along with the proof of electronic payment of tax payable under section 4-F or 4-G for the month for which the return relates.";

8. in rule 30-C, for sub-rule (3), the following sub-rule shall be substituted, namely:-

"(3) The return in electronic Form II-C containing the details of the tickets issued or sold for each day in a month shall be filed to the Entertainments Tax Officer along with the prescribed electronic return in Form II-D on or before the 10th day of the succeeding month. The returns shall be affixed with digital signature certificate of the proprietor:

Provided that if the return is not accompanied with digital signature certificate, then the return for each month shall be submitted electronically and a duly signed hard copy of the same shall be submitted to the Entertainments Tax Officer on or before the 10th day of the succeeding month along with proof of electronic payment of tax.";

9. in rule 39,-

(a) for sub-rule (2), the following sub-rule shall be substituted, namely:-

"(2) The proprietor shall pay the tax due electronically to the Government Treasury through the website of the Commercial Taxes Department, using either on-line net banking or on-line linked off-line payment facility of the Banks authorized by the Government.";

(b) sub-rule (3) shall be omitted;

10. for rule 48-D, the following rule shall be substituted, namely:-

"48-D. The permit holder or the certificate of registration holder, who appoints a person or a relative regularly as a manager or person-in-charge for the purpose of carrying on the work of the entertainment or amusement or television exhibition, or providing direct to home service or conducting any cricket tournament by the Indian Premier League or the Champions League Twenty 20 Cricket Tournament conducted by the Board of Control for Cricket in India such as appearing before the prescribed authority under the Tamil Nadu Entertainments Tax Act, filing of returns, signing of Forms II, II-C and II-D statements and requisition, etcetera, shall submit to the Entertainments Tax Officer concerned a declaration in electronic Form XX digitally signed by the partners / proprietor / permit holder / registration certificate holder, as the case may be, along with the Forms I or I-B or III or III-B. If there is any change in the manager or person in-charge, a fresh electronic Form XX shall be filed within three days from the date of such change:

Provided that if the holder of the permit or certificate of registration or the authorized person holds no digital signature, then he shall submit the declaration in electronic Form XX and furnish the manually signed hard copy of the declaration in electronic Form XX before the registering authority within ten days from the date of such change.";

11. in rule 49,-

(1) in sub-rule (1),-

(i) in clause (a), for the expression "appeal to the Deputy Commissioner of Commercial Taxes", the expression "appeal in Form XXIII to the Deputy Commissioner of Commercial Taxes" shall be substituted;
