The Government of Tamil Nadu having been satisfied that the lands specified in the schedule below have to be acquired for the purpose of Expansion of Existing Thoothukudi AirPort, and it having already been decided that the entire amount of compensation to be awarded for the lands are to be paid out of the funds controlled or managed by Transport Department, the following notice is issued under sub-section (1) of section 3 of Tamil Nadu Acquisition of Land for Industrial Purpose Act 1997

NOTICE

Under sub-section (1) of section 3 of the Tamil Nadu Acquisition of Land for Industrial Purpose Act 1997 (Tamil Nadu Act 10 of 1999). the Governor of Tamil Nadu hereby acquired the lands specified in the schedule below and measuring **14.38.5 hectares** to the same, a little more or less needed for the Expansion of Existing Thoothukudi AirPort, to wit for the establishment of Airport Development by the Transport Department of T.N. State Govt.
