No. SRO A-41(e-1)/2017.— The following notification Issued by the Ministry of Personnel, Public Grievances and Pension, Department of Personnel and Training, Government of India, New Delhi the dated 8th August 2017 is republished:-

No. GSR 1002 (E),— In exercise of the powers conferred by sub-section (1) of Section 3 of the All India Service Act, 1951 (61 of 1951), read with sub-rules (1) and (2) of Rule 4 of Indian Forest Service (Cadre) Rules, 1966, the Central Government in consultation with the Government of Tamil Nadu hereby makes the following regulations further to amend the Indian Forest Service (Fixation of Cadre Strength) Regulations, 1966, namely :—

- 1. (i) These regulations shall be called the Indian Forest Service (Fixation of Cadre Strength) Fifth Amendment Regulations, 2017.
 - (ii) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Indian Forest Service (Fixation of Cadre Strength) Regulations, 1966, in the Schedule, for the heading "Tamil Nadu" and the entries relating thereto, the following shall be substituted, namely:-
