DECLARATION OF MONDAY, THE 21ST OCTOBER, 2019 AS A PUBLIC HOLIDAY IN CONNECTION WITH THE BYE-ELECTION TO TAMIL NADU LEGISLATIVE ASSEMBLY FROM 75. VIKRAVANDI AND 227. NANGUNERI ASSEMBLY CONSTITUENCIES IN TAMIL NADU.

Under the Explanation to Section 25 of the Negotiable Instruments Act, 1881 (Central Act XXVI of 1881), read with the Notification of the Government of India, Ministry of Home Affairs, No.20-25-26, Public-I, dated the 8th June, 1957, the Governor of Tamil Nadu hereby declares Monday, the 21st October 2019, the date on which the poll for the Bye-election to Tamil Nadu Legislative Assembly from 75. Vikravandi and 227. Nanguneri Assembly Constituencies will take place, to be a public holiday for the areas comprised in the above Assembly Constituencies lying in Villupuram and Tirunelveli Districts respectively.

2 Further, all employees working in Villupuram and Tirunelveli Districts and the neighbouring Districts but registered as voters in 75.Vikravandi and 227. Nanguneri Assembly Constituencies, shall also be given a paid holiday on 21-10-2019.

3 All Government offices including industrial establishments of the Government and Government controlled bodies and all the educational institutions throughout the areas comprised in 75.Vikravandi and 227. Nanguneri Assembly Constituencies lying in Villupuram and Tirunelveli Districts will remain closed on 21-10-2019.
