Government of Tamil Nadu hereby notifies the sale of Tamil Nadu Government Stock (Securities) of **8-year** tenure for an aggregate amount of **Rs.500** crore (Nominal). The sale will be subject to the terms and conditions spelt out in this notification (called Specific Notification) as also the terms and conditions specified in the **General Notification No.404 (L)/W&M-II/2019, dated 13th March 2019** of Government of Tamil Nadu.

Object of the Loan:

- (i) To Finance Part of Capital expenditure of Plan Schemes and other Development Schemes under execution.
- (ii) Consent of Central Government has been obtained to the floatation of this loan as required by Article 293(3) of the Constitution of India.

Method of Issue:

The Government stock will be sold through the Reserve Bank of India, Mumbai Office (PDO), Fort, Mumbai-400 001 by auction in the manner as prescribed in paragraph 6.1 of the General Notification No.404 (L)/W&M-II/2019, dated 13th March 2019 at a coupon rate to be determined by the Reserve Bank of India at the yield based auction under multiple price formats.
