AMENDMENTS.

In the said Rules,-

(1) in rule 2, in sub-rule (1), in clause (i), —

for the expression “the Thanjavur City Municipal Corporation Act, 2013 (Tamil Nadu Act 24 of 2013) in respect of Thanjavur City Municipal Corporation; and

the Dindigul City Municipal Corporation Act, 2013 (Tamil Nadu Act 25 of 2013) in respect of Dindigul City Municipal Corporation;”,

the expression “the Thanjavur City Municipal Corporation Act, 2013 (Tamil Nadu Act 24 of 2013) in respect of Thanjavur City Municipal Corporation;

the Dindigul City Municipal Corporation Act, 2013 (Tamil Nadu Act 25 of 2013) in respect of Dindigul City Municipal Corporation;

the Hosur City Municipal Corporation Act, 2019 (Tamil Nadu Act 10 of 2019) in respect of Hosur City Municipal Corporation;

the Nagercoil City Municipal Corporation Act, 2019, (Tamil Nadu Act 11 of 2019) in respect of Nagercoil City Municipal Corporation; and

the Avadi City Municipal Corporation Act, 2019 (Tamil Nadu Act 24 of 2019) in respect of Avadi City Municipal Corporation;” shall be substituted;

(2) in rule 13, after the first proviso, the following proviso shall be added, namely:—

“Provided further that the officers or servants of the Central Government may also be appointed as Presiding Officers or Polling Officers, with the permission of the competent authority of that Government.”.

AMENDMENTS.

In the said Rules,-

(1) in rule 22, in sub-rule (1), for the expression “Councillors or Chairmen or Mayors” the expression “Councillors”, shall be substituted;

(2) for rule 23, the following rule shall be substituted, namely:-

“23. *Notice of Election.*-(1) In pursuance of the notification of the Tamil Nadu State Election Commission under rule 22, the Returning Officer shall cause to be published, on the appointed date, a notice of election in Tamil in Form 2 and also in any other language or languages in which the electoral roll is published for the election of councillors in the Town Panchayat or Municipality or Corporation and also affix a copy of the notice in two conspicuous places in the concerned wards.

(2) The notice of election shall contain the following particulars, namely:-

(a) the ward or wards for which elections are to be held;

(b) whether the ward is reserved or not; if reserved, whether it is reserved for Scheduled Caste or Scheduled Tribe and/or for woman;

(c) the dates on which, the place or places at which and the hours between which nomination papers shall be presented;

(d) the person or persons by whom the nomination papers will be received;

(e) the date on which and the hours at which and the place at which the nomination papers will be taken up for scrutiny;

(f) the last date on which and the hours upto which the nomination papers can be withdrawn;

(g) the date on which and the place or places at which and the hours between which the votes of the electors will be taken at the poll, should there be a poll;

(h) the date on which and the place or places and the hour at which the Returning Officer will commence the counting of votes;

(i) the date before which the election shall be completed; and

(j) the date on which the first meeting of the newly elected councillors shall be held, in the case of ordinary elections.”;

(3) in rule 24,-

(a) in sub-rule (2), for the expression “in the respective ward of the Town Panchayat or Municipality or Corporation, in the case of election of Councillors and in any ward of the respective Town Panchayat or Municipality or Corporation in the case of election of Chairman or Mayor, as the case may be”, the expression “in the ward of the Town Panchayat or Transitional Area or Municipality or Corporation in the election of councillors” shall be substituted;

(b) in sub-rule (2-A), in clause (a), the expression "Mayor or Chairman or" shall be omitted;

(c) sub-rule (6-a) shall be omitted;

(4) in rule 25 , in sub-rule(1),-

(a) for “the table”, the following Table shall be substituted, namely:-

(b) in the proviso, for the expression “Councillor or Chairman or Mayor”, the expression “Councillor” shall be substituted;

(5) in rule 26, in sub-rules (2) and (3), the following sentence occurring at the end, shall be omitted, namely:-

“Separate notice shall be prepared and published in respect of election of Chairman or Mayor and Councillors.”;

(6) in rule 27,-

(a) sub-rule (5-a) shall be omitted;

(b) in sub-rule (9), the following sentence occurring at the end, shall be omitted, namely:-

“Separate list shall be prepared and published in respect of election of Chairman or Mayor and Councillors.”;

(7) in rule 28, sub-rule (3-a) shall be omitted;

(8) in rule 33, for sub-rule (4), the following sub-rule shall be substituted, namely:-

“(4) The Returning Officer shall then complete the list of contesting candidates in Form 9 and publish the same at the office of the Town Panchayat or Municipality or Corporation as the case may be. The list shall also be published in two or more conspicuous places in the respective ward.”;

(9) in rule 47, in sub-rule (1), for the expression “Chairman or Mayor or Councillor”, the expression “Councillor” shall be substituted;

(10) in rule 54, in sub-rule (7), for the expression "Chairman or Mayor or Councillor" the expression "Councillor" shall be substituted;

(11) in PART VIII, for the heading, the following heading shall be substituted, namely:-

"ELECTION OF CHAIRMAN, VICE-CHAIRMAN, MAYOR, DEPUTY MAYOR, MEMBERS OF THE STATUTORY COMMITTEES AND CHAIRMAN OF WARDS COMMITTEE.";

(12) for rule 94, the following rule shall be substituted, namely:-

"94. Election of Chairman, Vice-Chairman, Mayor and Deputy Mayor.- The Chairman and Vice-Chairman of a Town Panchayat or Municipal Council or the Mayor and Deputy Mayor of a Corporation Council shall be elected by and from among the councillors of the wards of the Town Panchayat or Municipality or Corporation, as the case may be, in the manner prescribed in these rules, at a meeting specially convened by the Returning Officer:

Provided that where the office of the Mayor or Chairman of a Council is reserved for persons belonging to Scheduled Castes or Scheduled Tribes and /or for women under the provisions of the Act(s), only persons belonging to that category shall be eligible to contest the election for such office:

Provided further that where no such reservation has been made, nothing contained in the above proviso shall be deemed to prevent any member belonging to Scheduled Castes or Scheduled Tribes or women of a Town Panchayat or Municipality or Corporation, as the case may be, from contesting the election as Chairman or Mayor.";

(13) for rule 98, the following rule shall be substituted, namely;-

"98. Place and meeting for the election.- The election of the Chairman and Vice-Chairman of the Town Panchayat or Municipal Council or Mayor and Deputy Mayor of the Corporation Council or the election of Members of Statutory Committee or the election of Chairman of Wards Committee shall be held in the office of the concerned Town Panchayat or Municipality or Corporation where the meetings of the Town Panchayat or Municipality or Corporation Council are ordinarily held.";

(14) in rule 99,-

(a) in sub-rule (1),-

- (i) for the expression "Vice-Chairman", the expression "Chairman and Vice-Chairman" shall be substituted;
- (ii) for the expression "Deputy Mayor", the expression "Mayor and Deputy Mayor" shall be substituted;

(b) in sub-rule (2),-

- (i) for the expression "Vice-Chairman", the expression "Chairman or Vice-Chairman" shall be substituted;
- (ii) for the expression "Deputy Mayor", the expression "Mayor or Deputy Mayor" shall be substituted;

(15) in rule 100, after sub-rule (1), the following sub-rule shall be inserted, namely:—

"(2) Where the office of the Chairman or Mayor is reserved under the provisions of the Act(s) to persons belonging to Scheduled Caste or Scheduled Tribe, the candidate shall give in writing a further declaration that he or she belongs to the Scheduled Caste or Scheduled Tribe, as the case may be.";

(16) for rule 117, the following rule shall be substituted, namely:-

"117. Maximum Election Expenses.- (1) The total expenditure which can be incurred or authorised in connection with an election under these rules shall not exceed the amount mentioned in the Table below:-

(2) Any candidate, either by himself or by his election agent, whose expenditure has exceeded the amount mentioned above or who has not kept a separate and correct account of all expenditure in connection with the elections as specified in sub-rule (1) or rule 116 or who fails to lodge an account of election expenses with the authority concerned within the period specified in sub-rule (3) of rule 116, shall be deemed to have indulged in a corrupt practice for the purposes of the Act(s).";

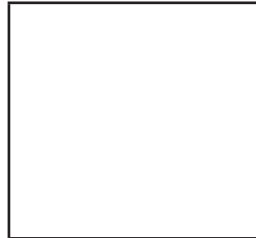

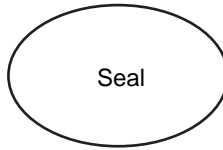

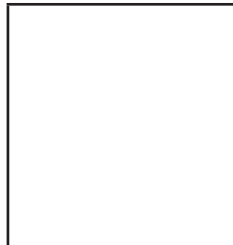
