[ELECTIONS - PANCHAYATS, TOWN PANCHAYATS, MUNICIPALITIES AND CORPORATIONS - CONDUCT OF - PERSONATION OF ELECTORS - PREVENTION - DOCUMENTARY EVIDENCES - NOTIFICATION OF.]

S.O.No.78/2011/TNSEC/EG-2, dated the 21st September 2011.

No. VI(2)/125(a-3)/2019.

In exercise of the powers conferred under rule 48-A of the Tamil Nadu Panchayats (Elections) Rules, 1995 and sub-rule (5) of rule 45 of the Tamil Nadu Town Panchayats, Municipalities and Corporations (Elections) Rules, 2006 and in supersession of the State Election Commission's earlier Notification, the State Election Commission hereby directs that all electors shall produce any one of the documents specified by this Commission for establishing their identity in order to exercise their franchise, when they come to the polling stations for voting. The Commission specifies the following documents for establishing the identity of such electors:-

- (i) Electoral Photo Identity Card (EPIC) provided under the authority of the Election Commission of India;
- (ii) Passport;
- (iii) Driving License;
- (iv) Service Identity Cards with Photograph issued to its employees by State / Central Government, Public Sector Undertakings, Local Bodies or Public Limited Companies;
- (v) Passbooks with photograph issued by Public Sector Banks / Post Office;
- (vi) PAN Card;
- (vii) Smart Card issued by RGI under NPR;
- (viii) Job Cards under MGNREGA Scheme with Photograph;
- (ix) Health Insurance Scheme Smart Cards with Photograph issued by the State or Central Government authorities.
- (x) Pension Documents with Photograph, such as Ex-servicemen's Pension Book/Pension Payment Order / Ex-servicemen's Widow / Dependent Certificates;
- (xi) Official Identity Cards issued to MPs/MLAs/MLCs; and
- (xii) Aadhaar Card.
- 2. It is clarified that any document, as enumerated above, which is available only for the Head of family, shall be allowed for the purpose of identification of other members of the family.

Provided the other members of the family can be identified on the basis of such document.

3. The State Election Commission makes it clear that failure or refusal on the part of the electors to produce any one of the said documents may result in the denial of supply of a ballot paper to them in Rural Local bodies and / or denial of allowing to cast their votes through Electronic Voting Machines in the case of Rural / Urban Local bodies.
