Government of Tamil Nadu hereby notifies the sale of Tamil Nadu Government Stock (Securities) of **10-year** tenure for an aggregate amount of **Rs.1000 crore** (Nominal). **The State Government will have the option to retain an additional amount of Rs.250 crore.** The sale will be subject to the terms and conditions spelt out in this notification (called Specific Notification) as also the terms and conditions specified in the **General Notification No.404(L)/W&M-II/2019, dated 13th March 2019** of Government of Tamil Nadu.

Object of the Loan:

1. (i) To Finance Part of Capital expenditure of Plan Schemes and other Development Schemes under execution.

(ii) Consent of Central Government has been obtained to the floatation of this loan as required by Article 293(3) of the Constitution of India.
