The Government of Tamil Nadu having been satisfied that the lands specified in the schedule below have to be acquired for Industrial Purposes, to wit, in favour of Mine-1 Expansion Scheme of NLC India Limited and it having already been decided that the entire amount of compensation to be awarded for the lands is to be paid out of the funds controlled or managed by NLC India Limited.
