Government of Tamil Nadu hereby notifies the sale of Re-issue of **6.33% Tamil Nadu State Development Loan 2030** issued on July 22, 2020 for an aggregate amount of **Rs.1000.00 crore** (Nominal). **The State Government will have the option to retain an additional amount of Rs.500 crore.** The sale will be subject to the terms and conditions spelt out in this notification (called Specific Notification) as also the terms and conditions specified in the General Notification No.404 (L) / W&M-II / 2019, dated 13th March 2019 of Government of Tamil Nadu.

#### **Object of the Loan:**

1. (i) To Finance part of Capital expenditure and other Development Schemes under execution.

(ii) Consent of Central Government has been obtained to the floatation of this loan as required by Article 293 (3) of the Constitution of India.
