Whereas it appears that the appropriate Government has given Administrative Sanction that a total of 1.48.60 hectares of dry land is required in the Pochampalli Taluk, Parandapalli Village in Pochampalli Taluk in Krishnagiri District for irrigation purpose, namely excavation of new supply canal from Barur Tank East main canal to feed 33 Tanks in Pochampalli and Uthangarai Taluks in Krishnagiri District. Environment impact Assessment Study for the irrigation project [i.e] excavation of new supply canal from Barur Tank East main canal to feed 33 tanks in Pochampalli and Uthangarai Taluks in Krishnagiri District in Tamil Nadu has been carried out by M/s Life Shell Labs India Private Limited, under the Section 3 [3] of the Environmental Protection Act,1986.
