No. 429/TN/2020 (3).- In exercise of the powers conferred by sub-section (1) of Section 13 (C) of the Representation of the People Act, 1950 (43 of 1950), the Election Commission of India hereby directs that following amendment shall be made in the Notification No 429/TN/2008(2) dated 18-6-2008 relating to appointment of Assistant Electoral Registration Officers for Assembly Constituencies in the State of Tamil Nadu

In column (2) of the Table appended to the said Notification for the existing entries mentioned against the Assembly Constituency shown in the column (1), the following entries shall be substituted.

The appointment of the Assistant Electoral Registration Officers in respect of 45. Kilvaithianankuppam (SC), 120. Coimbatore (South) and 121. Singanallur Assembly Constituency shall cease to be effective on completion of process of election in the constituency concerned.
