The Governor of Tamil Nadu having been satisfied that the lands specified in the Schedule below have to be acquired for Highways purpose for Forming Road Over Bridge in Salem District, Mettur Taluk, P.N.Patti (P.Nallagoundampatti), Veerakkalpudhur and Virthasampatti Villages at Km 17/10 of Tharamangalam-Nangavalli- Kunchandiyur State Highways road in lieu of existing Level Crossing No.21 railway Km 31/9-10 between Mechery and Mettur Railway Stations and it has already been decided that the entire amount of compensation to be awarded for the lands is to be paid out of the funds controlled or managed by the Divisional Engineer (Highways) Projects, Salem District after considering the cause shown by the owner

(or) other person having interest on such lands as the case may be do hereby publish the following notice under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002).

Under sub-section (1) of section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002) the Governor of Tamil Nadu hereby acquires the land specified in the Schedule below measuring to an extent of Acquisition of 13514.0 Sq.mtrs of R.Wet and R.Dry lands for forming Road Over Bridge in Salem District, Mettur Taluk, P.N.Patti (P.Nallagoundampatti), Veerakkalpudhur and Virthasampatti Villages at Km 17/10 of Tharamangalam-Nangavalli-Kunchandiyur State Highways road in lieu of existing Level Crossing No.21 railway Km 31/9-10 between Mechery and Mettur Railway Stations.
