AMENDMENTS TO THE SPECIAL RULES FOR THE TAMIL NADU PANCHAYAT DEVELOPMENT ENGINEERING SUBORDINATE SERVICE

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Panchayat Development Engineering Subordinate Service. (Section 56 in Volume III of the Tamil Nadu Services Manual 1970).

2. The amendments hereby made shall be deemed to have come into force with effect from 1st December 2020

AMENDMENTS.

In the said Special Rules .-

- (1) for rule 1, the following rule shall be substituted, namely:-
- "1. Constitution.- The service shall consist of the following categories of posts, namely:-

#### CATEGORY I:

- 1. Overseer
- 2. Junior Draughting Officer

#### CATEGORY II:

- 1. Road Inspector.";
- (2) for rule 2, the following rule shall be substituted, namely:-
- "2. Appointment.- Appointment to the posts specified in column (2) against the category in column (1) shall be made by the methods specified in the corresponding entries in column (3) thereof:-

#### Category I

Officer

- 1. Overseer (a) Direct Recruitment
- 2. Junior Draughting

Must possess a Diploma in Civil Engineering:

Provided that preference shall be given to the persons possessing a Bachelor's degree in Civil Engineering from any University or Institution recognized by the University Grants Commission.

(b) Promotion from Category II

(1) Must have rendered service as Road Inspector for a period of not less than seven years with Diploma in Civil Engineering; or

Must have rendered service as Road Inspector for a period of not less than ten years with ITI qualification

- (2) Must have passed the following tests, namely:-
- (i) The Account Test for Public Works Department Officers and Subordinates;
- (ii) Paper IV of the Departmental Test for Officers of the Panchayat Development Department, namely the Tamil Nadu Panchayats, Act, 1994 and the rules and orders issued there under.

The ratio for appointment to the Category I by promotion and by direct recruitment shall be in the ratio of 1:3 and the following rotation shall be followed, while making appointment:

- (1) Promotion
- (2) Direct Recruitment
- (3) Direct Recruitment
- (4) Direct Recruitment

#### Category II

1. Road Inspector Direct Recruitment

Must possess an I.T.I. Certificate in Civil Draughtsmenship from a Government recognized Institute:

Provided that preference shall be given to the persons possessing a Diploma in Civil Engineering;

(4) in rule 7,-

- (i) in sub-rule (a) for the expression "appointed to the post of Overseer", the expression "appointed to a post in Category I" shall be substituted;
- (ii) in sub-rule (b) for the expression "direct recruitment as Overseer has failed", the expression "direct recruitment to a post in Category I fails," shall be substituted;
- (5) in rule 8, for the expression "Overseer or Road Inspector", the expression "Overseer, Junior Draughting Officer or Road Inspector" shall be substituted.
- (6) in rule 10, for the expression "Overseer and Road Inspector", the expression "Overseer, Junior Draughting Officer and Road Inspector" shall be substituted.
