The Governor of Tamil Nadu having been satisfied that the lands specified in the Schedule below are required for the purpose of provision of Project facilities such as Bus Bay, junction improvement at Grade Rotary to Chennai Outer Ring Road Phase-II at No.135.Minjur Village, Ponneri Taluk, Tiruvallur District and it having already been decided that the entire amount of compensation to be awarded for the lands is to be paid out of the funds controlled or managed by the Chief Engineer (Construction and Maintenance), Highways Department and after having considered the cause shown by the owners or other persons having interest on such lands, as the case may be, do hereby publish the following notice under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002).

#### NOTICE

Under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002), the Governor of Tamil Nadu hereby acquires the Wet and Dry land specified in the schedule below measuring to an extent of **10395 Sq.mts.**, for the purpose of provision of Project facilities for Outer Ring Road Phase-II at No.135.
