The Government of Tamil Nadu having been satisfied that the lands specified in the schedule below are acquired under Tamil Nadu Road Sector Project - II for Highways purpose for Widening of SH-222, Omalur - Mecheri Road at KM (1/150 to 14/320) Olaiipatti Village in Mettur Taluk, Salem District and it having already been decided that the entire amount of compensation to be awarded for the lands to be paid out of the funds controlled and managed by the Divisional Engineer(H), Salem (TNRSP II), Tamil Nadu after having considering the cause shown by the owner or other persons having interest on such lands as the case may be do hereby publish the following notice is issued under sub-section (1) of section 15 of the Tamil Nadu Highways Act, 2001 (TN Act 34 of 2002).
