The Government of Tamil Nadu having been satisfied that the lands specified in the Schedule below are acquired under Chennai Peripheral Ring Road Project for Highways Department purpose to wit, for formation of road for providing connectivity from Ennore Port to Mahabalipuram (from Km. 43+886 to 45+910 and 47+176 to Km. 47+727) at No.25, Keelanur Village, Tiruvallur Taluk, Tiruvallur District and it having already been decided that the entire amount of compensation to be awarded for the lands to be paid out of the funds controlled and managed by the Highways Department and after having considering the cause shown by the owner or other persons having interest on such lands, as the case may be, do hereby publish the following notice under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002) read with the Tamil Nadu Land Acquisition Laws (Revival of Operation, Amendment and Validation) Act, 2019.

Under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002), read with the Tamil Nadu Land Acquisition Laws (Revival of Operation, Amendment and Validation Act, 2019) the Governor of Tamil Nadu hereby notifies that the Wet, Dry, Manavari and Natham lands specified in the schedule below and measuring to an extent of 1,48,207 Sq.Mtrs. of lands are acquired in No.25.Keelanur Village, Tiruvallur Taluk, Tiruvallur District to the same a little more or less needed for the purpose to wit for formation of road for providing road connectivity from Ennore Port to Mahabalipuram (from Km. 43+886 to 45+910 and 47+176 to Km. 47+727) as part of Chennai Peripheral Ring Road Project, by Highways department.
