NOTIFICATION FOR USE OF AADHAAR UNDER SECTION 7 OF THE AADHAAR (TARGETED DELIVERY OF FINANCIAL AND OTHER SUBSIDIES, BENEFITS AND SERVICES) ACT, 2016 (CENTRAL ACT 18 OF 2016) FOR ENROLLMENT OF BENEFICIARIES UNDER THE POLICY DIRECTION OF GOVERNMENT OF TAMIL NADU IN RESEPCT OF KALAIGNAR MAHALIR URIMAI THITTAM, WHICH PROVIDES Rs. 12,000/- PER ANNUM TO IMPROVE THE LIVELIHOOD OF WOMEN, ENHANCE THE STANDARD OF LIVING AND PAVE THE WAY FOR THEM TO LIVE WITH SELF – RESPECT IN SOCIETY WHICH INVOLVES EXPENDITURE FROM THE CONSOLIDATED FUND OF THE STATE.

WHEREAS, as per the policy direction of the Government of Tamil Nadu, Special Programme Implementation Department is implementing the Kalaignar Mahalir Urimai Thittam.

AND WHEREAS, the above said scheme implemented by Special Programme Implementation Department, Secretariat, Chennai-09 is funded by the Government of Tamil Nadu, which involve expenditure from the Consolidated Fund of the State;

NOW, THEREFORE, under section 7 of the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016 (Central Act 18 of 2016), the Governor of Tamil Nadu hereby notifies the following, namely,-

- (1) An eligible individual desirous of availing benefits under above schemes is required to furnish proof of possession of Aadhaar number or undergo Aadhaar authentication.
- (2) An eligible individual desirous of availing benefits under the above Schemes, who does not possess an Aadhaar number or has not yet enrolled for Aadhaar, is hereby required to apply for Aadhaar enrolment provided he or she is entitled to obtain Aadhaar as per section 3 of the said Act.

(3) The applicants are hereby requested to apply in any Aadhaar enrolment center or permanent enrolment center (list available at <a href="www.uidai.gov.in">www.uidai.gov.in</a>) to get enrolled for Aadhaar.

In order to avail the benefits in a convenient and hassle free manner by the beneficiaries, the District Collectors concerned shall make a wide publicity through electronic and print media to make beneficiaries aware of the requirements of Aadhaar under the above scheme and they may be advised to get themselves enrolled in the nearest Aadhaar Enrollment Centres available in their areas, in case they are not already enrolled.
