In exercise of the powers conferred by Articles 229(1) and (2) of the Constitution of India read with Rule 28(b) of the Madras High Court Service Rules, 2015 and of all other powers connected thereto, the Hon'ble The Chief Justice is pleased to make the following amendments to the Madras High Court Service Rules, 2015.

#### AMENDMENT-I

In Annexure B of Rule 14B, the existing entries occurred in Point No.(iv) of Clause I, under the heading **"Procedure for Selection Process for Promotion"**, shall be substituted by the following entries:-

"(iv) The Registry shall submit the list of eligible Officers in feeder category for promotion to next higher level post in Division I, in the ratio of 1:3 against the number of vacancies in the promotional post."
