DISQUALIFICATION OF 7TH WARD MEMBER, RAMANATHAPURAM PANCHAYAT UNION, RAMANATHAPURAM DISTRICT UNDER THE TAMIL NADU PANCHAYATS ACT, 1994.

WHEREAS, the opinion of the Tamil Nadu State Election Commission was sought for, regarding the disqualification of Thiru.K.Manoharan, 7th ward member, Ramanathapuram Panchayat Union, Ramanathapuram District, as required under sub-section (2) of Section 41 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994) as he has undertaken panchayat works as a contractor through M/s. Sri Sai & Co. Constructions as one of partner in the said firm vide partnership deed No.473334, dated 05.08.2020;

AND WHEREAS, the Tamil Nadu State Election Commission, after conducting an enquiry and verifying all the relevant documents, has confirmed that Thiru.K.Manoharan, 7th ward member, Ramanathapuram Panchayat Union, has undertaken panchavat works as a contractor through M/s. Sri Sai & Co. Constructions as one of the partner in the said firm vide partnership deed No.473334, dated 05.08.2020 and opined that Thiru.K.Manoharan, 7th ward member, Ramanathapuram Panchayat Union, Ramanathapuram District is disqualified to continue as ward member of the said Panchayat Union under clause (c) of sub-section (3) of Section 38 of the said Act:

NOW THEREFORE, under sub-section (1) of Section 41 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994), the Governor of Tamil Nadu hereby decides that Thiru.K.Manoharan, S/o.Thiru.Ramalingam, 7th ward member, Ramanathapuram Panchayat Union, Ramanathapuram District has become disqualified from holding the office of ward member of the said Panchayat Union under clause (c) of sub-section (3) of Section 38 of the said Act, as he has undertaken panchayat works as a contractor through M/s. Sri Sai & Co. Constructions.
