ISSUE OF POSTAL BALLOT TO COVID-19 SUSPECT OR AFFECTED PERSONS

The following Notifications of the Election Commission of India, Nirvachan Sadan, Ashoka Road, New Delhi-110 001, dated 16th March, 2024 is published:

In pursuance of the provisions of clause (c) of Section 60 of the Representation of the People Act, 1951, the Election Commission hereby specifies that the Covid-19 suspect or affected person, certified by competent authority, who applies for voting by postal ballot paper, and subject to verification of his request by the Returning Officer concerned, would be a class of persons to give his vote by postal ballot in the current General Elections to the House of the People and Legislative Assemblies of Andhra Pradesh, Arunachal Pradesh, Odisha & Sikkim, 2024 and bye-elections to 26 Assembly Constituencies in 13 States (as per Annexure) scheduled to be notified on 20.03.2024, 28.03.2024, 12.04.2024, 18.04.2024, 26.04.2024, 29.04.2024 and 07.05.2024 under Section 30 of the Representation of the People Act, 1951, as per the provisions in Part-III A of the Conduct of Elections Rules, 1961, as amended *vide* Ministry of Law & Justice, Govt. of India, Notification SO No. 1964(E), dated 19th June, 2020 read with the directions and guidelines issued by the Election Commission on the subject.

ELECTORS WITH PHYSICAL DISABILITY

The following Notifications of the Election Commission of India, Nirvachan Sadan, Ashoka Road, New Delhi-110 001, dated.16th March, 2024 is published:

In pursuance of the provisions of clause (c) of Section 60 of the Representation of the People Act, 1951, the Election Commission hereby specifies that the elector above the age of 85 years and elector with physical disability (benchmark) as already marked/flagged in the data base of the electoral rolls of the State and, who requests for voting by postal ballot paper and subject to the verification of his request by Returning Officer concerned, would be a class of persons to give his vote by postal ballot in the current General Elections to the House of the People and Legislative Assemblies of Andhra Pradesh, Arunachal Pradesh, Odisha & Sikkim, 2024 and bye elections to 26 Assembly Constituencies in 13 States (as per Annexure) to be notified under Section 30 of the Representation of the People Act, 1951, as per the provisions in Part-III A of the Conduct of Elections Rules, 1961, as amended *vide* Ministry of Law & Justice, Govt. of India, Notifications SO No. 3786(E), dated 22nd October, 2019, SO No.3778(E), dated 23rd August, 2023 and SO No. 995(E), dated 1st March, 2024.
