REMOVAL OF CHAIRMAN OF GANGAVALLI PANCHAYAT UNION COUNCIL, SALEM DISTRICT UNDER THE TAMIL NADU PANCHAYATS ACT, 1994.

WHEREAS, a written notice of the intention to make a motion expressing want of confidence in Tmt.B.Priya, Chairman, Gangavalli Panchayat Union Council, Salem district, signed by nine members, out of the sanctioned strength of eleven members of the said Council, together with a copy of the motion proposed to be made and a written statement of charges against the said Chairman have been delivered to the Revenue Divisional Officer, Attur, Salem district in person by nine members as per sub-section (2) of section 212 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994);

AND WHEREAS, the Revenue Divisional Officer, Attur, Salem district caused a copy of the statement of charges along with a copy of the notice of motion to be delivered, to the said Chairman Tmt.B.Priya and she submitted her reply to the charges;

AND WHEREAS, a motion expressing want of confidence in Tmt.B.Priya, Chairman, Gangavalli Panchayat Union Council, Salem district had been carried with a support of nine members out of the sanctioned strength of eleven members of the said Panchayat Union Council in the meeting convened by the Revenue Divisional Officer, Attur, Salem district on the 18th December 2023 after following the procedures specified in the said section 212 and forwarded the same to the Government:

NOW THEREFORE, in exercise of the powers conferred by sub-section (13) of section 212 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994), the Governor of Tamil Nadu hereby removes Tmt.B.Priya, Chairman, Gangavalli Panchayat Union Council, Salem district from the office of the Chairman of the said Panchayat Union Council with immediate effect
