AMENDMENTS TO NOTIFICATION UNDER THE TAMIL NADU PROHIBITION ACT, 1937

[G.O.Ms.No. 11, Home, Prohibition and Excise (III), 29th February 2024, மாசி 17, சோபகிருது, திருவள்ளுவர் ஆண்டு–2055.]

No. II(1)/HOPE/4(i)/2024.

In exercise of the powers conferred by sub-section (1) of section 18-B of the Tamil Nadu Prohibition Act, 1937 (Tamil Nadu Act X of 1937), the Governor of Tamil Nadu hereby makes the following amendments to the Prohibition and Excise Department Notification No.II(1)/PE/239(d)/81, published at page 2 of Part II-Section 1 of the Tamil Nadu Government Gazette Extraordinary, dated the 1st May 1981, as subsequently amended.

2. The amendments hereby made shall come into force on the 1st March, 2024.

AMENDMENTS

In the said Notification, in the TABLE, under the entry "Indian Made Foreign Spirits (brand names of which are specified in the Annexure) other than sacramental wine" in column (1),-

- (1) under the heading "(i) ORDINARY BRANDS", for the expression "which does not exceed Rs.780 per case in respect of brands manufactured in the State", the expression "which does not exceed Rs.924 per case in respect of brands manufactured in the State" shall be substituted;
- (2) under the heading "(ii) MEDIUM BRANDS", for the expression "between Rs.781 to Rs.849 per case in respect of brands manufactured in the State", the expression "between Rs.925 to Rs.993 per case in respect of brands manufactured in the State" shall be substituted; and

- (3) under the heading "(iii) PREMIUM BRANDS",-
 - (i) in clause (a) for the expression "Rs.850 to Rs.2349 per case", the expression "Rs.994 to Rs.2493 per case" shall be substituted; and
 - (ii) in clause (b), for the expression "Rs.2350 and above per case", the expression "Rs.2494 and above per case" shall be substituted.
