**Order: No. 220, Public (Special-A), 11th May 2011.**

Accepting the proposal of the High Court of Madras sent by the Registrar General, High Court of Madras, Chennai, the Government direct that the following orders of deputation, repatriation and appointment in respect of certain District Judges:—

(i) Thiru A.M. Basheer Ahamed, District Judge of Tamil Nadu State Judicial Service, functioned as Principal District Judge, Dindigul, now under compulsory wait, be deputed to the Puducherry Judicial Service for being posted as Judge, Family Court, Pondicherry in the place of Thiru E.M.K.S. Siddharthar;

(ii) Thiru D. Ramabathiran, District Judge of Puducherry Judicial Service, functioning on deputation as Principal District Judge, Cuddalore, be repatriated to his parent department viz., Puducherry Judicial Service for being posted in the Union Territory of Puducherry;

(iii) Thiru K. Uthirapathy, District Judge of Puducherry Judicial Service, functioning on deputation as Member Secretary, Union Territory of Puducherry Legal Services Authority, Pondicherry be appointed as Principal District Judge, Cuddalore, in the place of Thiru D. Ramabathiran on deputation basis in the Tamil Nadu State Judicial Service; and

(iv) Thiru E.M.K.S. Siddharthar, District Judge of Puducherry Judicial Service, functioning as Judge, Family Court, Pondicherry be appointed as District and Sessions Judge, District Court No. II, Kancheepuram in the existing vacancy on deputation basis in the Tamil Nadu State Judicial Service.
