

Order: No. 16, Public (Special-A), 5th January 2011. Under rule 5 of the Tamil Nadu State Judicial Service (Cadre and Recruitment) Rules, 2007, the Government in consultation with the Hon'ble High Court of Madras, Chennai, hereby appoint the following persons as District Judges (Entry Level):—

The above District Judges (Entry Level) will draw a pay of Rs. 51,550/- in the Scale of Pay of Rs. 51550-1230-58930-1380-63070 and other usual allowances and they will be on probation for a total period of 2 years from the date of joining duty within a continous period of three years. The selected candidates are requested to furnish Physical Fitness Certificate direct to the Registrar General, High Court of Madras under intimation to Government.

3. During the period of probation, the above District Judges will undergo:---

- (i) Training as Civil Judge (Junior Division) for a period of not lelss than six months;
- (ii) Training as Civil Judge (Senior Division) for a period of not less than six months; and
- (iii) Training in Forensic Science for a period of not less than two months.
- 4. The above District Judges (Entry Level) should also pass the Account Test for Executive Officers within the period of probation. Only after satisfactory completion of the training, the above District Judges will be posted to act as District Judge (Entry Level).
- 5. The posting orders for training as Civil Judges (Junior Division), Civil Judges (Senior Division), etc. and joining instructions will be issued by the Hon'ble Madras High Court. The above District Judges (Entry Level) are informed that other terms and conditions specified in Tamil Nadu State Judicial Service (Cadre and Recruitment) Rules, 2007, shall apply to them.
