Shiek Allaudin, 3rd Ward Member, Pavattakudi Village Panchayat, Nannilam Panchayat Union, Thiruvarur District by the Commission was returned with the postal endorsement as "Left India - Returned to sender". Besides, Thiru R. Thyagarajan, Village Administrative Officer, Pavattakudi has given a written statement during the enquiry that Thiru A.Shiek Allaudin, 3rd Ward Member, Pavattakudi Village Panchayat has gone of foreign with regard to employment. The said Commission has also stated that on verification of the attendance register and records of Pavattakudi Village Panchayat, it has been confirmed that, Thiru A.Shiek Allaudin, 3rd Ward Member of the said Village Panchayat has not attended more than three consecutive meetings of the said Village Panchayat held on or after 20th March, 2008 and thereby opined that the said Thiru A. Shiek Allaudin, 3rd Ward Member, Pavattakudi Village Panchayat, Nannilam Panchayat Union, Thiruvarur District is disqualified to continue as Ward Member of the said Pavattakudi Village Panchayat, under clause (i) of sub-section (3) of Section 38 of the said Act;

Now, therefore, under sub-section (1) of Section 41 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994), the Governor of Tamil Nadu hereby decides that Thiru A. Shiek Allaudin, 3rd Ward Member, Pavattakudi Village Panchayat, Nannilam Panchayat Union, Thiruvarur District, has become disqualified from holding the office of 3rd Ward Member of the said Pavattakudi Village Panchayat, under clause (i) of sub-section (3) Section 38 of the said Act as he has absented himself from three consecutive meetings of the said Village Panchayat held on or after 20th March 2008.
