Exemption of certain shops of Nalli Chinnasami Chetty, etc., for certain period under Tamil Nadu Shops and Establishments Act.

[G.O.(D)No. 28, Labour and Employment (K2), 7th February 2011, தை 24, திருவள்ளூர் ஆண்டு-2042.]

No.II(2)/LE/89/2011.—In exercise of the powers conferred by Rule 6 of the Tamil Nadu Shops and Establishments Act, 1947 and in supersession of orders issued in G.O.(D)No. 262, Labour and Employment Department, dated 30th March 2007, the Governor of Tamil Nadu exempts temporarily for a further period of three years with effect from the date of publication of the Notification in the *Tamil Nadu Government Gazette* to the following shops of Nalli Chinnasami Chetty from the provision of Rule 11(1) of the Tamil Nadu Shops and Establishments Act:--

1. The Nalli Chinnasami Chetty, No.9, Nageswaran Road, T. Nagar, Chennai-17.

2. The Nalli Silks Sales Depot, No. 3, Jadamuni Koil Street, Madurai-625 001.

3. The Nalli Silks Sales Depot, No.315/316, Raja Street, Coimbatore-641 001.

4. The Nalli Sales Depot, No.49-E, Bharathiyar Salai, Trichy-620 001.

5. The Nalli Silks Sales Depot, 64-G, Swami Sannadhi Street, Tirunelveli-627 006.

The exemption is granted under Section 11(1) of the above said Act to the above Shops subject to the following conditions:—

(i) Opening and closing hours of the establishment should be subject to Section 7 of the Tamil Nadu Shops and Establishments Act, 1947 and the notification made there under.

(ii) Hours of work of employees including overtime of all the employees of the establishment should be subject to Section 9 of the Tamil Nadu Shops and Establishments Act, 1947. Payment for overtime work shall be according to the provisions of Section 31 of the above act.

(iii) Spread over of hours of work of employees of the establishment shall be subject to Section 10 of the Tamil Nadu Shops and Establishments Act, 1947.

(iv) All the employees in the establishment shall be granted weekly holidays in accordance with the provisions of Section 11 (2) of the Tamil Nadu Shops and Establishments Act, 1947. A time table of weekly holidays allowed to the employees to be put upon the notice board of the branch where the employees are working. The time table of weekly holidays for each employee for the succeeding months should be displayed on the notice board of the branch where employee is employed on or before the last day of the previous month.

(v) If employees are required to work on national or festival holidays the provisions of the Tamil Nadu Industrial Establishments (National and Festival Holidays) Act should be followed.

(vi) Other Registers/Forms to be maintained under the Tamil Nadu Shops and Establishments Act, 1947 and the Tamil Nadu Shops and Establishments Rules should be continued to be maintained.

(vii) The name board of the establishment shall be exhibited in Tamil in the manner prescribed in Rule 15 of the Tamil Nadu Shops and Establishments Rules.

(viii) Exemption will be cancelled if any genuine complaints are received from the employees.

(ix) If any one of the conditions above is violated, exemption will be cancelled.
