No. II(1)/AG/9/2011.—In exercise of the powers conferred by Clause 26 of the Fertilizer (Control) Order, 1985 and in supersession of Agriculture Department Notifications No. II(1)/AG/51/88 and II(1)/AG/53/88 published at Page 30 of Part II—Section I of the *Tamil Nadu Government Gazette*, dated the 30th March 1988, the Governor of Tamil Nadu hereby appoints the Joint Director of Agriculture of the district to be the registering authority for the purpose of issuing certificate of Manufacturer of the Nitrogen, Phosphate, Potassium Mixtures (Physical or Granulated), Micronutrient Mixtures, Special Mixture, Organic Fertilizer and Bio Fertilizer within their respective jurisdiction and the Additional Director of Agriculture (Seeds) in the office of the Commissioner of Agriculture, Chennai to be the registering authority for the purpose of issuing certificate of manufacturer for the notified grades of micronutrient mixtures of other States to be manufactured in Tamil Nadu and Marketed outside the State.

No. II(1)/AG/10/2011.—In exercise of the powers conferred by Clause 26 of the Fertilizer (Control) Order, 1985 the Governor of Tamil Nadu hereby appoints all the Assistant Director of Agriculture (Quality Control Cell) to be the Notified Authorities for the acceptance of the Memorandum of Intimation and for issuing letter of authorization and renewal of letter of authorization in respect of wholesale dealers/retail dealers under the said order within their respective jurisdiction and the Deputy Director of Agriculture (Fertilizer) in the Office of the Commissioner of Agriculture, Chennai to be the Notified authority for the acceptance of Memorandum of Intimation and for issuing letter of authorization and renewal to the manufactures/importers of straight, Complex Fertilizers, Straight Micronutrients and for the Bio Fertilizers (Liquid/Solid), Organic Fertilizers, Micronutrient Mixtures, any other grades of notified Fertilizer coming from other States.

No. II(1)/AG/11/2011.—In exercise of the powers conferred by Clause 32A of the Fertilizer (Control) Order, 1985 and in supersession of Agriculture Department Notification No. II(1)/AG/54/88 published at Page 31 of Part II—Section 1 of the *Tamil Nadu Government Gazette*, dated 30th March 1988, the Governor of Tamil Nadu hereby appoints,

- (1) The Deputy Director of Agriculture (Fertilizer) in the Office of the Commissioner of Agriculture, Chennai as the appeallate authority to here any appeal filed against the orders passed by the Assistant Director of Agriculture (Quality Control) regarding:—
 - (i) Suspending or cancelling authorization letter or barring from carrying on the business of selling Fertilizer;
 - (ii) Non-issuance of authorization letter within the stipulated period and
 - (iii) Non-issuance of amendment in authorization letter within the stipulated period;
- (2) The Additional Director of Agriculture (Seeds), in the Office of the Commissioner of Agriculture, Chennai as the appellate authority in respect of appeal filed against the orders passed by the Joint Director of Agriculture or Deputy Director of Agriculture (Fertilizer) in the Office of the Commissioner of Agriculture, Chennai;
- (3) The Commissioner of Agriculture, Chennai as the appellate authority to here the appeals filed against the orders passed by the Additional Director of Agriculture (Seeds) in the Office of the Commissioner of Agriculture, Chennai.
