No. SRO A-46/2018.—The following draft amendments to the Tamil Nadu contract Labour (Regulation and Abolition) Rules, 1975 which is proposed to be made in exercise of the powers conferred by Section 35 of the Contract Labour (Regulation and Abolition) Act, 1970 (Central Act 37 of 1970), is hereby published for information of all persons likely to be affected thereby as required under sub-section (1) of Section 35 of the said Act.
