Amendment to the Tamil Nadu Payment of Wages Rules.

No. SRO A-67/2018.—In exercise of the powers conferred by Section 26 of the Payment of Wages Act, 1936 (Central Act 4 of 1936), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Payment of Wages Rules, 1937, the draft of the same having been previously published, as required by sub-section (5) of Section 26 of the said Act.

DRAFT AMENDMENT.

In the said Rules, in the proviso to rule 18, after the expression "the Tamil Nadu Factories Rules, 1950", the expression, "or Combined Annual Return in Form XXV under Schedule XIII as required in rule 242 of the Tamil Nadu Building and other Construction Workers (Regulation of Employment and Conditions of Service) Rules, 2006" shall be inserted.

Amendments to the Chennai Corporation Legal Service Rules.

No. SRO A-68/2018.—In exercise of the powers conferred by clause (i) of sub-section (1) of Section 86 read with clause (a) of sub-section (2) of Section 347 of the Chennai City Municipal Corporation Act, 1919 (Tamil Nadu Act IV of 1919), the Governor of Tamil Nadu hereby makes the following amendments to the Chennai Corporation Legal Service Rules-

AMENDMENTS

In the said Rules,-

- (1) in rule 2,-
 - (a) before the entry "1. Class I-B Law Officer", the entry "1. Class I-A Senior Law Officer" shall be inserted;
 - (b) the existing entries 1 and 2 shall, respectively, be renumbered as "2" and "3";
- (2) in rule 3, in THE TABLE, before the entry "Law Officer" in column (1) and the corresponding entries in column (2) thereof, the following entries shall, respectively, be inserted, namely:-

"Senior Law Officer"

- "(1) By direct recruitment; or
- (2) By promotion from the post of Law Officer in Class I-B; or
- (3) By deputation from the Law Department of Government of Tamil Nadu";

- (3) in rule 4,-
- (a) in the Table under the sub-heading 'Other Qualifications',-
 - (i) before the entry "1. Law Officer" in column (1) and the corresponding entries in columns (2) and (3) thereof, the following entries shall, respectively, be inserted namely:-

- "1. Senior Law Officer"
- (a) By direct recruitment
- (1) Must be a Law Graduate;
- (2) Must be an Advocate enrolled on the rolls of the Bar Council of Tamil Nadu or any other Bar Council in India;
- (3) Must have an experience of not less than ten years in the High Court;
- (b) By promotion from the post of Law Officer in Class I-B

Must have served as Law Officer for a period of not less than ten years in Greater Chennai Corporation;

(c) By deputation from the Law Department of Government of Tamil Nadu" Must be not below the rank of Deputy Secretary to Government in Law Department in the Government of Tamil Nadu";

- (ii) the existing entries in serial numbers 1 and 2 shall, respectively, be renumbered as serial numbers 2 and 3;
- (b) in the Table under the sub-heading '(1) Age',-
 - (i) before the entry "1. Law Officer" in column (1) and the corresponding entry in column (2) thereof, the following entries shall, respectively, be inserted, namely:-

"1. Senior Law Officer"

"40 years";

- (ii) the existing entries in serial numbers 1 and 2 shall, respectively, be renumbered as serial numbers 2 and 3;
- (4) in rule 9, in "The TABLE", for the entries in column (1) and the corresponding entries in column (2) thereof, the following entries shall, respectively, be inserted, namely:-

" 1. Senior Law Officer" "Rs.61900-196700 (level 26)"

"2. Law Officer" "Rs.59300-187700 (level 25)"

"3. Assistant Law Officer" "Rs.36400-115700 (level 16).".
