Further, nomination papers shall be enclosed in an envelope superscripting the name of the Electorate, and sent by Registered Post (Acknowledgment due), so as to be received by the Returning Officer within the date and hour fixed or delivered either in person or by a messenger to the Returning Officer within the last date and hour fixed. Nomination papers that are not enclosed in an envelope superscripted and sent by Registered Post or are not delivered in person or by messenger as required above shall be declared invalid.

III. An elector shall be eligible to subscribe either as a proposer or as a seconder in nomination papers, only as many times as there are vacancies but not more.

Nomination papers shall be enclosed in an envelope superscribing the above elections (each election separately) and sent by Registered Post (Acknowledgment due), so as to be received by the Returning Officer/Registrar, Manonmaniam Sundaranar University, Abishekapatti, Tirunelveli, within the date and hour fixed or delivered either in person or by messenger to the Returning Officer within the last date and hour fixed. Nomination papers that are not enclosed in an envelope, superscribed and sent by Registered Post or are not delivered in person or by messenger as required above shall be declared invalid.
